To ensure that pet families receive authentic and quality products, the sale of PetIQ brand products are intended for sale only through its direct-to-consumer website(s) and through authorized retail partners ("Authorized Partners"). Because many of our products contain active ingredients registered with the U.S. Environmental Protection Agency and regulated by the U.S. Food and Drug Administration and departments of agriculture in all fifty states, production, packaging, storage, distribution, and marketing is closely controlled and monitored to ensure pet safety and product efficacy. These quality and safety processes give consumers confidence in our products and serve as a critical component of the value of our brands. As such, **the unauthorized reselling, distributing, or selling of any PetIQ products is prohibited.**

AUTHORIZED RESELLER OBLIGATIONS

PetIQ has formed partnerships with trusted Authorized Partners. These Authorized Partners have agreed to ensure that their holding, selling, and marketing practices meet our storage, safety, and labeling requirements.

Sales by Authorized Partners that do not comply with this Authorized Reseller Policy will not be eligible for certain services and benefits, including coverage under any warranties or guarantees. PetIQ may, in its sole discretion, immediately revoke the right to sell PetIQ product by Authorized Partners for any reason, including, but not limited to, the mishandling of product, inadequate storage, tampering, or relabeling, or the adulteration or dilution of PetIQ products.

INTELLECTUAL PROPERTY

PetIQ owns all rights in and to the PetIQ brands, names, logos, trademarks, service marks, trade dress, copyrights, formulations, methods of making, and all other

intellectual property rights related to PetIQ products. Authorized Partners are granted a limited, non-exclusive, non-transferable, revocable license to use the PetIQ brand intellectual property solely for purposes of marketing and selling PetIQ products. This license will immediately cease upon termination of the seller's status as an Authorized Partner.

MAP POLICY

UNAUTHORIZED RESALE PROHIBITED
